Money for Moray has secured funding from the Scottish Government Investing in Communities Fund to be awarded in Moray to support projects which will make Moray “A Fairer Moray for All”. The funding will be allocated to East Moray and West Moray¹ with an additional allocation to the 8 Associated School Groups for projects which will be put forward by and for young people.

Money for Moray wants to put **YOU** in control of how and where it's spent.

The '**Money for Moray**' initiative lets the local community decide for themselves which projects are needed in their area.

What can you apply for?

Projects must be sustainable and will:

1 Deliver on **one or more** of the following priorities:-

- Accessibility/ connectivity to services and support
 - Transport;
 - Fuel Poverty;
 - Rural areas of Moray
- Health and Wellbeing
 - Promoting outdoor activities to improve mental wellbeing and reduce social isolation;
 - Food insecurity
- Growing a diverse and sustainable economy
 - Employability and life skills;
 - Volunteering;
 - Intergenerational projects

2 Provide additional or new services.

3 Include a community engagement/ community capacity building/ community empowerment element.

4 Take place in Moray and will be aimed at improving the situation that people in challenging circumstances find themselves.

Projects must meet all four criteria.

Your imagination has no limit!

¹ East Moray consists of Speyside, Keith, Milne's and Buckie Associated School Groups.

West Moray consists of Forres, Elgin (x2) and Lossiemouth Associated School Groups.

On the application form, please tick the appropriate box.

If your project is Moray wide please tick East/ West according to where your organisation is based.

What you cannot apply for is ongoing running costs such as salaries, heating and lighting, rent, maintenance etc.

Who can apply?

If you are a new or existing local community/ voluntary group based in Moray – even an informal group²– you can **apply for funding from £200 to £4,000** to put your ideas into action. **(Only one application per group/ organisation/ partnership).**

Who can not apply?

- National or commercial organisations
- Groups/ organisations with an annual income in excess of £50,000
- Community Interest Companies (CICs)
- Individuals

How do you apply?

To apply for the funding a fully completed application must be received before **5pm on Friday 28 January 2022**. Applications can be made online at www.moneyformoray.org or if you require a printed copy please contact one of the named persons (on the front page).

Confirmation of any necessary planning permissions and/or consents – for example outdoor fitness equipment on local authority land – will be sought from applicants.

Your Project must be completed by 31st December 2023.

If your idea meets the criteria, you will be required to make a short virtual presentation which will be posted online for the public to view. You will also be required to attend a “marketplace” event which will be open to the public and will give them the opportunity to ask questions about your project. The Marketplace events will take place in April 2022 with dates, times and venues to be notified.

All those aged 8 and over will be eligible to vote on the applications.

- *do not need to have a constitution*
- *do not need a bank account but will require the support of a constituted group prepared to accept monies on their behalf.*

Conditions of Grant

Any grant awarded may only be used for the purposes of the Project as described within this application and for no other purposes whatsoever.

1. Changes/Delays to the Project

- 1.1. Your organisation (the grantee) must tell Money for Moray immediately in writing of anything that significantly delays or threatens the project's completion.
- 1.2. Your organisation will tell Money for Moray immediately if there is to be any material variation in the delivery of the Project and this will require approval in advance from Money for Moray.
- 1.3. Money for Moray has the right to request repayment if your organisation fails to meet any of these terms and conditions.
- 1.4. Your organisation shall not transfer any part of the grant to another organisation or individual.

2. Payment of Grant

- 2.1. The grant shall be paid to your organisation by Money for Moray.
- 2.2. Your organisation will agree to make satisfactory progress with the Project and complete it on or before the 31 December 2023.
- 2.3. Your organisation will not use the grant to pay for any spending commitments made before the date of the grant award and will return any unspent monies.

3. Final Project Report

- 3.1. Your organisation shall, within 4 weeks of completing the Project, submit a report to Money for Moray summarising the Project outcome(s).
- 3.2. Your organisation shall keep and maintain adequate and proper records and original receipts relevant to expenditure as approved in the grant application.

4. Monitoring

- 4.1. Money for Moray may monitor the progress of the Project at any time throughout the period of award and expect your organisation to provide any necessary information.

5. Publicity

- 5.1. The Grantee shall agree, on acceptance of the award, to publication, electronically or otherwise, information concerning the amount of public funding allocated to your Project.
- 5.2. The Grantee shall, where reasonably practicable, acknowledge in all publicity material relating to the Project Money for Moray and the Scottish Government and agree to publicity and marketing to promote the award of the grant.
